Hi Lauryn,

If Dr. Michael Macias and Dr. Alison Simon would like to use parts of their dissertation in a new publication they are co-authoring with others they are free to do so.

Authors who have a completed and published a dissertation at FIU retain all copyrights to their dissertation.

FIU is simply licensed to distribute the dissertation through our repository. If the publisher requires a letter, the letter should be from Dr. Macias and Dr. Smith since they are the copyright holders.

There is one caveat. If the data used in the dissertation is not their original data or used under some other license or agreement with a third party, they would need to honor that agreement. For example, we often have students who are working within a larger research project who may be restricted by the terms of the research project to share or use that data in other ways. Or another example would be if they retrieved the data from other published sources and used it with permission from another researcher they would need to request permission to use it in a different publication. Again, it is up to the authors of the dissertation to comply with those agreements.
